### APPLICABLE COUNTY CODE SECTIONS

- CITY CODE STATES THAT ALL DOGS ARE REQUIRED TO BE VACCINATED AGAINST RABIES AND LICENSED.
  - WITHIN THIRTY (30) DAYS AFTER REACHING THE AGE OF FOUR (4) MONTHS, OR
  - WITHIN THIRTY (30) DAYS OF ACQUIRING THE DOG, OR
  - WITHIN THIRTY (30) DAYS AFTER ENTERING THE JURISDICTION OF THESE ORDINANCES.
- FAILURE TO OBTAIN A LICENSE AS LISTED IN NUMBER 1 ABOVE, OR TO RENEW THE LICENSE BY THE EXPIRATION DATE WILL RESULT IN A LATE FEE.
- RABIES VACCINATION MUST BE EFFECTIVE THROUGH THE ENTIRE LICENSING PERIOD.
- DOGS MUST BE LEASHED SECURELY WHEN OFF THE OWNER'S PREMISES.
- LICENSE TAGS SHALL BE FIRMLY ATTACHED TO THE DOG'S COLLAR AND WORN AT ALL TIMES.
- DOG LICENSE FEES ARE NOT REFUNDABLE.

### To apply for a dog license in person or by mail:

- Complete all information on the front of the application
- Provide proof of current rabies vaccination.
- Provide proof of spay or neuter.
- We accept Visa, MasterCard, Discover and cash. No checks.

### License Expiration Information

License Expirations are assigned the longest time period permissible under current state and local laws based upon the license duration you select and the time left remaining on the rabies vaccination submitted with the application. (See Applicable County Code Section # 3)
